Gardeners must agree to all NCG Rules before submitting this application.

- Garden fees are \$40 per 10'x20' plot payable by November 30th for renewing plots. Four hours of volunteer time is required to keep the price low for everyone.
- If you would rather not do the volunteer hours, plot rental is \$80.00 per 10'x20' plot.
- NCG is an Organic Garden where conventional weed killers and pesticides are NOT allowed.
- College events and courses may periodically close the access road and parking lot. Closures will be communicated in advance.

RELEASE OF ALL CLAIMS for Gardeners

Welcome to The Northwoods Community Garden, Inc. This document, which is a legal contract between you and The Northwoods Community Garden, Inc., describes the terms under which you may use an assigned plot, or volunteer, in the Garden. By signing this document, you confirm that you understand and agree to its terms, including the waiver terms, set out below.

I, _____ (print name), hereby apply to be a Participant in the Garden for the 2023 season. I am an adult and have read, understand and agree to the following:

1. I am aware of the risks and hazards that may arise to me or my guests through participation in the Garden, and I assume any damages, expenses and liabilities incurred through participation and in the event of an accident, illness or other unforeseen occurrence.
2. I hold harmless The Northwoods Community Garden, Inc., the Garden Board, volunteers, other gardeners, and Nicolet College (cooperating landowner) from all claims of damages, demands, and any actions whatsoever, including those based on negligence, in any manner arising out of my, or my guests, participation in the Garden. I understand that by signing this Release, I give up all rights to any claims or legal action for any losses, damages, injury or costs that may incur.
3. I understand that by using a plot in this Garden, I give permission to use any photographs of me and my family taken in the Garden for local newspapers, on the Garden website or Facebook page, for as long as I participate in the Garden.
4. I acknowledge that my right to use the Garden Plot is a license, personal to me, that is revocable by The Northwoods Community Garden, Inc. I understand that I will not receive a refund, reimbursement for expenses or other payment if I decide not to use the plot or if The Northwoods Community Garden, Inc. terminates my right to use the plot if I do not adhere to the Garden rules.
